

City of Largo Summer Camp Scholarship Application-2019

Scholarship Application Guidelines

- Applications will be accepted beginning on Wednesday, January 2 at 8am
- Applications may be turned in at the Southwest Recreation Center or Highland Recreation Center
- Applications must be completely filled out and have all supporting documentation
 - Copy of the parent/guardian 2018 Income Tax Summary sheet showing the total annual income and number of dependents (social security numbers should be blacked out prior to submitting the form)
 - Copy of proof of residency (parents drivers license or utility bill)
- The child that is listed on the scholarship application must be listed as a dependent on the income tax summary page.
- Income verification brackets are based on the number of dependents listed on the income tax summary page.
- Scholarships will be awarded in the order they are received. Approval notifications will begin in February.
- Families will be notified via email and/or US Mail after their scholarship application has been reviewed.
- Preference will be given to Largo Residents. If funding is available, applications from Non Residents will be considered.

Scholarship Registration/Attendance Requirements-Initial next to each one

- _____ I understand that being awarded a scholarship does not guarantee my child a space in camp. Once approved, anyone that is awarded a scholarship must register and make their first payment within two weeks in order to secure their scholarship funding. Registration for residents and non-residents begins on Jan 2.
- _____ I understand that my child may not miss more than one day per week.
- _____ I understand that a physician's note or legal documentation is required for any absences that exceed the one day per week.
- _____ I understand that I will be responsible for full price of the camp week for any weeks that my child does not meet the attendance requirements.
- _____ I understand that my child must be in camp each day from 9a-4p.
- _____ I understand that if the scholarship requirements are not met, my child will not be eligible for a scholarship in future camp years.
